Description of Additional Services:

As requested via email and in our virtual meeting on November 18, 2022, Devenney Group Ltd., Architects (DGL) and our consultant will provide additional design services that includes a high-level analysis to determine the applicability of the SPC-4D and NPC-4D upgrade regulations for the following buildings at the Mendocino Coast Campus:

SPC-4D

- Main Hospital Building (BLD -00469)
- Central Plant Building (BLD-00470)

NPC-4D

- Main Hospital Building (BLD-00469),
- Central Plant Building (BLD-00470),
- Emergency Addition West (BLD-00471),
- Respiratory Neurophysiology Lab (BLD 02787),
- Emergency Generator Shelter (BLD 02788),
- Emergency Addition East (BLD-00473)

We will provide an assessment for each of these buildings. These assessments will:

- Identify whether the SPC-2 buildings are a candidate for upgrade (or not).
- Identify scope and process involved in the detailed SPC-4D evaluation and upgrade
- Provide scoping information for NPC compliance required by year 2030 to meet SB 1953 requirements.

We will complete a high-level review of the structural improvements recommended for seismic compliance, provide graphic exhibits for scheduling/phasing of these proposed improvements, to minimize impacts to ongoing operations of the hospital.

These documents will be provided to the Owner for review, to determine the future direction they wish to take for the Mendocino Coast Campus. The scope of this additional service authorization does not include submittals to HCAI and it is not expected that such submittals will be required at this time.

This work will require up to three (3) coordination meetings with the client's representatives.

This work is considered effort above and beyond the scope of our currently agreed upon basic services.
